I am pleased to write in support of Washington Rural Broadband Cooperative's application for the Rural Utilities Service (RUS) Broadband Initiatives Program (BIP) grant through the American Recovery and Reinvestment Act of 2009. Funding from this grant would bring high speed internet to the Mt. Baker Foothill region, as well as a high bandwidth broadband service.

Washington Rural Broadband Cooperative's project will enhance public safety, education, medicine, and economic development in its community. It will interconnect police and fire departments and enable cell phone carriers to provide service at a quicker response time to emergency incidents. In the medical field, doctors from metropolitan hospitals will be able to provide rapid assessment and guidance to first responders through video conference and tele-presence.

Funding would also assist in the educational and economic areas. High speed internet access made available to all households would help the school district meet upcoming federal mandates to keep schools functioning during a pandemic as well as increase the availability of enriched curriculum. It would allow for the development of small internet based businesses as well as better access to adult basic and continuing educational opportunities and workforce development.
